2018 Financial Audit:



Jed's is Awarded the Restaurant Contract:



Jedediah's Corporation was recently awarded the restaurant contract for the next three years. The design project for the restaurant expansion is underway and we look forward to working with Jed's on this project to create an improved restaurant space.

Two New Transportation Options Coming to JAC:



As of November 1st, JH Shuttle will no longer operate at the airport. The airport is excited to announce:

- Taxi2Fly will replace the Ride2Fly program giving passengers more flexibility and provider options. Passengers will need to look at the Airport's website to see which taxi providers offer this service and will need make a reservation in advance of their departure/arrival. The rate for Taxi2Fly will be \$20/rider from the Town Parking Garage.
- TaxiPool will be introduced to promote ridesharing amongst passengers who are willing to have multiple destinations. Each destination will receive a \$10 discount off the posted fare. Airport employees wanting to park at the parking garage for personal travel will need to utilize Taxi2Fly after November 1st, 2018.
